Firstly, I trust you and your family are all safe and well during this Covid 19 crisis.

I write to update you regarding the implications of the cancellation of the French trip, the liquidation of USIT travel, and the potential for a claim for a refund of the payments made by you to USIT directly, towards the trip. While we had sought to cancel the trip this had not been processed prior to the liquidation, so you will submit your claim as if you were still due to travel.

The school has been advised of the claim form (available on our website) which you must complete and return to "Commission for Aviation Regulation, Alexandra House,6 Earlsfort Terrace, Dublin 2 D02 W773 " To assist, we have attached a completed sample of those sections of the form where we know the details (sections 2 and 3 copy attached). You should fill in these details on the form. The other sections,1,4,5,6 and 7 should be completed by you. The document should be returned to the address above **BY THE 26th May Deadline** to facilitate consideration of your claim with the insurance policy form and the itinerary which are both attached.
